

Jersey Voucher Pay Monthly Mobile Telephone Promotion 2017

Promotion Specific Terms of reference

1. This offer is available to new and existing Customers of JT's post-paid mobile telephone service who between 1st August 2017 and 31st October 2017:
 - a) sign-to a £15 or more JT Pay Monthly plan on a 24 month device rental payment plan with a selected handset from the range specified by JT from JT's retail outlet in Jersey or Guernsey, while stocks last (the "£15 Plan"); or
 - b) sign to a £6 JT Pay Monthly Plan on a 24 month device rental payment plan with a selected handset from the range specified by JT from JT's retail outlet in Jersey or Guernsey, while stocks last (the "£6 Plan").
2. An existing post-paid mobile Customer of JT signing up to the £15 Plan during the Promotional Period will receive a £100 voucher for one of JT's approved retailers on JT's approved retail partner list or a free weekend ticket to the Weekender Festival (the "Festival") to be held in Jersey on the 2nd and 3rd September as selected by the Customer, whilst stocks last (the "Voucher").

An existing post-paid mobile Customer of JT signing up to the £6 Plan during the Promotional Period will receive a £50 voucher for one of JT's approved retailers on JT's approved retail partner list or a free ticket to the House on Herm event (the "Event") to be held in Herm on the 23rd September 2017 as selected by the Customer, whilst stocks last (the "Lite Voucher").

Only one Voucher or Lite Voucher is available per Customer. A Customer may not purchase more than one Plan or Lite Plan for the same mobile telephone number.

3. A new Customer who, during the Promotional Period: (a) ports their mobile telephone number from another mobile telephone service provider to JT's post-paid mobile service, and (b) upon successful completion of the porting process purchases the £15 Plan or £6 Plan will receive a Voucher or Lite Voucher, according to term (2) above. Only one Voucher or Lite Voucher is available per new Customer. A new Customer may not purchase more than one £15 Plan or £6 Plan for the same mobile telephone number.
4. This offer is only available to new and existing Customers of JT signing up for the £15 Plan or £6 Plan directly in JT's retail outlet in Jersey or Guernsey.
5. The Voucher or Lite Voucher will be issued at the time the Customer signs-up to the £15 Plan or the £6 Plan.
6. If the Voucher or Lite Voucher is not taken by the Customer at the time they sign-up to the £15 Plan or the £6 Plan, the Voucher or Lite Voucher may at JT's discretion be issued to the Customer at a later date provided that the Customer claims the Voucher or Lite Voucher within a period of 1 month after the Customer as signed-up for the £15 Plan or the £6 Plan.
7. Use of the Voucher or Lite Voucher is subject to the relevant retail partner's terms and conditions, and JT shall not be responsible for any action taken by the relevant retail partner in this respect.
8. Use of the Festival ticket is subject to the terms and conditions of Jersey Weekender Limited, and JT shall not be responsible for any action taken by Jersey Weekender Limited in this respect.
9. Use of the Event ticket is subject to the terms and conditions of IBZ.TV, and JT shall not be responsible for any action taken by IBZ.TV in this respect.
10. The provision of the Voucher or Lite Voucher is subject to availability whilst JT's stock of Vouchers or Lite Vouchers lasts. If JT's stock of Vouchers or Lite Vouchers is exhausted prior to the end of the Promotional Period then the Promotional Period ends when JT's stock of Vouchers or Lite Vouchers is exhausted.

11. The offer is non-transferable and non-refundable and Customers cannot receive cash, or an alternative item, in place of the Voucher or Lite Voucher.
12. New Customers must take photographic identification with them when they visit JT's Jersey or Guernsey retail outlet to port their mobile telephone number.
13. This offer may not be taken in conjunction with any other Pay Monthly mobile promotion offered by JT during the Promotional Period.
14. JT reserves the right to amend the range of devices which are subject to this offer at any time during the Promotional Period in its sole discretion.
15. Devices must be taken on a 24 month device rental payment plan.
16. These terms of reference are in addition to JT's Post-paid Mobile Telephone Service Terms and Conditions and JT's Equipment Purchase Terms and Conditions, which are available online at www.jtglobal.com. Any capitalised term not defined in these terms of reference shall have the meaning given to it in the Equipment Purchase Terms and Conditions.
17. A cooling off period of 14 days applies to the £15 Plan and the £6 Plan, and will only be accepted if: (a) the handset is returned in the same condition in which it was sold together with all packaging, accessories and documentation; and (b) the Voucher or Lite Voucher is returned unused. A Customer cancelling a £15 Plan or a £6 Plan during the cooling off period who has redeemed the Voucher or Lite Voucher will be charged the full face value of the Voucher or Lite Voucher.
