

Broadband & Landline Voucher Promotion 2017

Promotion Specific Terms of reference

1. This offer is available to new Customers who sign to any of the broadband and landline plans detailed below for a minimum contract period of 24 months between 8th August 2017 to 31st October 2017 (the "Promotional Period"):

In Jersey:

- (i) JT Entry Level Broadband (20GB) and a landline; and
- (ii) JT Broadband (100GB) and a landline.

In Guernsey:

- (i) JT 20Mb Broadband and a landline;
- (ii) JT 40Mb Broadband and a landline; and
- (iii) JT 60Mb Broadband and a landline.

(together the "Plans")

2. An existing Customer of JT signing up to any of the Plans for a minimum contract period of 24 months during the Promotional Period will receive a voucher of £50 as selected by the Customer from JT's approved retail partner list (the "Voucher").

Only one Voucher is available per Customer. A Customer may not purchase more than one of the Plans for the same landline telephone number.

3. A new Customer who, during the Promotional Period signs to one of the Plans for a minimum contract period of 24 months will receive a voucher of £50 as selected by the Customer from JT's approved retail partner list (the "Voucher"). Only one Voucher is available per new Customer. A new Customer may not purchase more than one of the Plans for the same landline telephone number.

4. This offer is only available to new Customers of JT signing to any of the Plans for a minimum contract period of 24 months directly in JT's retail outlets in Jersey or Guernsey.

5. The Voucher will be issued at the time the Customer signs to any of the Plans for a minimum contract period of 24 months.

6. If the Voucher is not taken by the Customer at the time they sign to any of the Plans for a minimum contract period of 24 months, the Voucher may at JT's discretion be issued to the Customer at a later date provided that the Customer claims the Voucher within a period of 1 month after the Customer has signed to any of the Plans for a minimum contract period of 24 months.

7. Use of the Voucher is subject to the relevant retail partner's terms and conditions, and JT shall not be responsible for any action taken by the relevant retail partner in this respect.

8. The provision of the Voucher is subject to availability whilst JT's stock of Vouchers lasts. If JT's stock of Vouchers is exhausted prior to the end of the Promotional Period then the Promotional Period ends when JT's stock of Vouchers is exhausted.

9. The offer is non-transferable and non-refundable and Customers cannot receive cash, or an alternative item, in place of the Voucher.

10. This offer may not be taken in conjunction with any other promotion offered by JT during the Promotional Period for the Plans.

11. These terms of reference are in addition to JT's Exchange Line Services and Data Services Terms and Conditions applicable to the Plans, which are available online at www.jtglobal.com. Any capitalised term not defined in these terms of reference shall have the meaning given to it in the Exchange Line Services and Data Services Terms and Conditions.

12. A cooling off period of 14 days applies to the Plans, and will only be accepted if the Voucher is returned unused. A Customer cancelling any of the Plans during the cooling off period who has redeemed the Voucher will be charged the full face value of the Voucher.
