



Pay as you go Sunset on Herm Ticket Promotion 2017

Promotion Specific Terms of reference

1. This offer is available to new Customers who between 25th August 2017 and 23rd September 2017 (the “Promotional Period”):
 - a) port in their mobile telephone number from another mobile telephone service provider to JT’s Pay as you go mobile telephone service, and who purchase a top-up credit for the value of £49 to apply to their pre-paid mobile telephone Account (the “£49 Top-Up”) from JT’s retail outlet in Jersey or Guernsey; or
 - b) port in their mobile telephone number from another mobile telephone service provider to JT’s Pay as you go mobile telephone service, and who purchase a top-up credit for the value of £99 to apply to their pre-paid mobile telephone Account (the “£99 Top-Up”) from JT’s retail outlet in Jersey or Guernsey.
2. A newly ported Pay as you go mobile Customer of JT purchasing the £49 Top-Up during the Promotional Period will receive a free adult ticket to the Sunset on Herm event to be held in Herm on 24th September 2017 (the “Ticket”).

A new Customer who, during the Promotional Period: (a) ports their mobile telephone number from another mobile telephone service provider to JT’s Pay as you go mobile service, and (b) upon successful completion of the porting process purchases the £49 Top-Up will receive a free Ticket (while stocks last). A new Customer may not purchase more than one Top-Up for the same mobile telephone number.

Only one Ticket is available per Customer. A Customer may not purchase more than one Top-Up for the same mobile telephone number.

3. A newly ported Pay as you go mobile Customer of JT purchasing the £99 Top-Up during the Promotional Period will receive a free adult ticket and two free teen tickets to the Sunset on Herm event to be held in Herm on 24th September 2017 (the “Tickets”).

A new Customer who, during the Promotional Period: (a) ports their mobile telephone number from another mobile telephone service provider to JT’s Pay as you go mobile service, and (b) upon successful completion of the porting process purchases the £99 Top-Up will receive the Tickets (while stocks last). A new Customer may not purchase more than one Top-Up for the same mobile telephone number.

Only one batch of Tickets is available per Customer. A Customer may not purchase more than one Top-Up for the same mobile telephone number.

4. The £49 Top Up or the £99 Top Up must be purchased within 7 working days of the successful completion of the porting process.
5. This offer is only available from JT's retail outlets in Jersey and Guernsey.
6. The Ticket or Tickets will be issued at the time the Customer purchases the £49 Top-Up or £99 Top-Up.
7. If the Ticket or Tickets are not taken by the Customer at the time that they purchase the £49 Top Up or the £99 Top Up the Ticket may at JT's discretion be issued to the Customer at a later date provided that the Customer claims the Ticket or Tickets within a period of 1 month after the Customer has purchased the £49 Top-Up or the £99 Top Up.
8. Use of the Ticket or Tickets is subject to the terms and conditions of IBZ.TV, and JT shall not be responsible for any action taken by IBZ.TV in this respect.
9. The Ticket or Tickets do not include travel from Jersey to Guernsey or any accommodation.
10. The provision of the Ticket or Tickets is subject to availability whilst JT's stock of Tickets lasts. If JT's stock of Tickets is exhausted prior to the end of the Promotional Period then the Promotional Period ends when JT's stock of Tickets is exhausted.
11. The offer is non-transferable and non-refundable and Customers cannot receive cash, or an alternative item, in place of the Ticket or Tickets.

The Top-Up Credit of £49 or £99 will be applied to the Customer's Account at the time of purchase in JT's retail outlet, and will expire ninety (90) days after being applied to the Customer's Account. The Top-Up Credit of £49 or £99 or any unused part thereof is not transferable to a post-paid account.
13. New Customers must take photographic identification with them when they visit JT's Jersey or Guernsey retail outlet to port their mobile telephone number.
14. This offer may not be taken in conjunction with any other Pay as you go mobile offered by JT.
