



Design a Pumpkin Competition October 2022 Terms of Reference

PROMOTER

1. The promoter of this Competition is JT (Jersey) Limited, No 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB (“**JT**”).

THE COMPETITION

1. The chance to win a £50 toy voucher by colouring in/designing the pumpkin template and emailing same to marketing@jtglobal.com (the “**Competition**”) between 14 October 2022 and 29 October 2022 at 5pm (the “**Competition Period**”).
2. To enter this Competition each entrant must during the Competition Period complete all of the following steps:
 - (a) colour in/design the pumpkin template (a copy of which is provided at Appendix 1 of these terms of reference) (the “**Template**”);
 - (b) provide all of the information required as detailed on the Template;
 - (c) have the Template signed by a parent/guardian; AND
 - (d) email the completed Template to marketing@jtglobal.com.
4. JT will draw two (2) entrant winners (one (1) resident in Jersey and one (1) resident in Guernsey) from all valid entries (the “**Winner**”) by 5pm on 31 October 2022 (the “**Draw**”) and each Winner will be entitled to:
 - (a) for the Jersey resident Winner, a voucher issued by Bambola, Jersey for use in its store to the value of £50 to be collected from the JT retail store in Jersey; OR
 - (b) for the Guernsey resident Winner, a voucher issued by Creaseys, Guernsey for use in its store to the value of £50 to be collected from the JT retail store in Guernsey,

(each a “**Prize**” and together the “**Prizes**”).
5. Entrants that have not completed the process pursuant to clause 3 hereof to the satisfaction of JT, shall not be eligible to be entered into the Draw.
6. The Prizes are non-transferable and non-refundable and each Winner cannot receive cash, or an alternative item, in place of a Prize.

10. The Winners shall be contacted via the contact details provided on the Template. The Winners will also be announced on the Design a Pumpkin Facebook competition post with each Winner's first name and surname initial and their island residence along with each Winner's pumpkin design. JT shall make all reasonable efforts to contact the Winners but if a Winner does not respond to notification from JT by 5pm on 3 November 2022, then JT reserves the right to select a new Winner(s).
11. The Prizes will be available for collection from 1 November 2022 (the "**Collection Date**") from the relevant JT retail store in Jersey or Guernsey.
12. Subject to receiving parental or guardian consent, the Winners may have their name and photograph taken collecting their Prize which may be used by JT for reasonable publicity purposes in connection with this Competition.
13. A winning claim is subject to a full verification process, and a Prize may not be claimed without valid confirmation by JT as to the identity of the Winners' parent or guardian. The decision of JT as to who has won a Prize is final.
