



Fairphone 3+ Mobile Phone Promotion October 2021 Promotion Specific Terms of Reference

PROMOTER

1. The promoter of this Promotion is JT (Jersey) Limited, No 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB (“**JT**”).

THE PROMOTION

2. The chance to win a Fairphone 3+ mobile phone where an entrant comments on JT’s Facebook post between 14 October 2021 and 12 noon on 22 October 2021 (the “**Promotional Period**”) with the reason why they would like to win a Fairphone 3+ mobile phone (the “**Promotion**”).
3. To enter this Promotion each entrant must during the Promotional Period complete all of the following steps:
 - (a) logon to an active Facebook account;
 - (b) navigate to the JT Social Facebook page (www.facebook.com/JTsocial);
 - (c) comment on the JT Social Fairphone 3+ Competition Facebook post with the reason why they would like to win a Fairphone 3+ mobile phone; AND
 - (d) click the ‘Like’ button on the JT Social Facebook Page.
4. JT will draw two (2) entrant winners at random (one (1) resident in Jersey and one (1) resident in Guernsey) from all valid entries (the “**Winner**”) by 5pm on 22 October 2021 (the “**Draw**”) and each Winner will be entitled to:

 - (b) for the Guernsey resident Winner, a Fairphone 3+ mobile phone to be collected from the JT retail store in Guernsey,(each a “**Prize**” and together the “**Prizes**”).
5. Entrants that have not completed the process pursuant to clause 3 hereof to the satisfaction of JT, shall not be eligible to be entered into the Draw.
