

# Find The JT Easter Egg Competition – March/April 2023 Terms of Reference

## **PROMOTER**

1. The promoter of this Competition is JT (Jersey) Limited, No. 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB ("**JT**").

#### THE COMPETITION

- 2. The chance to win a £150 JT Shop voucher by finding the five (5) JT Easter Eggs on its website at <a href="mailto:shop.jtglobal.com">shop.jtglobal.com</a> and completing the online "Find the JT Easter Eggs" Competition entry form (the "Competition") between 29 March and 9 April 2023 ("the "Competition Period").
- 3. To enter this Competition each entrant must, during the Competition Period, complete each of the following steps:
  - (a) navigate their internet browser to the JT online shop website at shop.jtglobal.com;
  - (b) find each of the five (5) different patterned JT Easter Eggs (the "Eggs"); AND
  - (c) complete the online Competition entry form, including a description of the webpage location of each of the Eggs; AND
  - (d) provide their contact details on the online Competition entry form.
- 4. JT will draw one (1) Competition entrant winner at random from all valid Channel Island entries (the "Winner") by 5pm on 11 April 2023 (the "Draw"). The Winner will be entitled to a JT Shop voucher valued at £150 (the "Prize").
- 5. Entrants that have not completed each of the steps in the process pursuant to clause 3 above to the satisfaction of JT, shall not be eligible to be entered into the Draw.
- 6. The Prize is non-transferable and non-refundable and the Winner cannot receive cash, or an alternative item, in place of the Prize.
- 7. The Winner shall be contacted via the contact details provided on the online Competition entry form. The Winner will also be announced on the Competition Facebook post with the Winner's name and their island residence.
