



**Free Gift with device purchase Offer summer 2023**  
**Terms of Reference**

1. This Offer is made: (a) in Guernsey, by JT (Guernsey) Limited of Sarnia House, Le Truchot, St Peter Port, Guernsey, GY1 1GR; and (b) in Jersey, by JT (Jersey) Limited of No 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB (each, “**JT**”).
2. This Offer is available to all Customers of JT who purchase an Eligible Device (defined in paragraph 3 below) between 5 July 2023 and 6 October 2023 (the “**Promotional Period**”) and elect to pay for such Device by means of a Mobile Device Payment Plan with a duration of 12, 24 or 36 months.
3. The devices subject to this Offer (each an “**Eligible Device**”) shall be as advertised by JT, made available in JT’s Jersey and Guernsey retail stores, and as published online at [www.jtglobal.com](http://www.jtglobal.com), as may be amended from time to time depending on stock availability
4. A Customer who purchases an Eligible Device on a Mobile Device Payment Plan is eligible, at the time of purchase, to receive a free gift selected at random by JT from the following list for the relevant island (each a “**Free Gift**”):

The lists of Free Gifts in paragraph 4 above show the Free Gifts available as at the start of the Promotional Period, and each individual Free Gift shall be available for as long as JT’s stock of that Free Gift lasts. Once JT’s stock of a Free Gift has been exhausted, that item shall be removed from the list of available Free Gifts. For the avoidance of doubt, JT shall ensure that there is always at least one item from the relevant list available to a Customer as a Free Gift at the time of purchasing an Eligible Device.
6. The Free Gift is non-transferable and non-refundable and the Customer cannot receive cash, or an alternative item, in place of the Free Gift.
7. This Offer shall be subject to any other terms and conditions applicable to the purchase of the Eligible Device and/or an associated service. For example, if a new Customer of JT purchases an Eligible Device when opening a new JT account, the Customer shall be subject to JT’s standard verification process and JT shall not provide the Free Gift to the Customer without valid confirmation by JT as to the identity of the Customer. JT’s decision in this regard shall be final.
8. JT reserves the right to modify or cancel the Offer at any time without prior notice.



9. This Offer is available to Customers of JT purchasing an Eligible Device directly in JT's retail outlets in Jersey or Guernsey or online at [www.jtglobel.com](http://www.jtglobel.com). Where a Customer purchases an Eligible Device online, the Free Gift shall be delivered to the Customer with the Eligible Device.
10. This Offer may be used in combination with any other offer or promotion by JT.
11. To the full extent permitted by law, JT and its associated companies and any agencies (the "**Relevant Parties**"), exclude all liability for any loss (including any damage, claim, injury, cost or expense) whatsoever which is suffered or incurred by any person arising out of, or in any way connected with the Offer or the Free Gift including without limitation:
  - (a) any direct, indirect, economic or consequential loss; or
  - (b) any loss arising from any negligent act or omission of any Relevant Parties.

JT will not accept liability for any Free Gift lost or damaged, nor for any associated costs to claimants.

A cooling-off period of fourteen (14) days applies to Mobile Device Payment Plans which are added to a JT Customer's account, but will only be accepted in respect of an Eligible Device where the Customer returns the undamaged Eligible Device, cables and associated packaging to JT in a condition acceptable to JT at its sole discretion together with the Free Gift.
13. A Customer who cancels a Mobile Device Payment Plan in respect of an Eligible Device but either (a) returns the Eligible Device and/or the Free Gift in a condition which is unacceptable to JT; or (b) does not return the Free Gift, will be charged the full face value of the Free Gift.
