

TERMS OF REFERENCE

Win an iPhone Air Competition Terms of Reference

THE PROMOTER

1. The promoters of this Competition are JT (Jersey) Limited, No. 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB and JT (Guernsey) Limited, East Wing, Trafalgar Court, Les Banques, St Peter Port, Guernsey GY1 3PP (together, “JT”).

THE COMPETITION

2. The chance to win an Apple iPhone Air by completing the action as detailed in section 3, between 14 August 2026 and 9am on 12 November 2026 (“the **Competition Period**”).
3. To enter this Competition, each entrant must, during the Competition Period, complete the following steps:
 - (i) complete the online JT 5G quiz at <https://itglobal.typeform.eu/5G-survey>; AND
 - (ii) provide their contact details on the online Competition entry form.
4. JT will draw one Competition entrant winner at random from all valid Channel Islands entries (the **Winner**) by 5pm on 13 November 2026 (the **Draw**). The Winner will be entitled to receive an Apple iPhone Air, 256GB (the **Prize**).
5. Entrants that have not completed each of the steps in the process pursuant to clause 3 above to the satisfaction of JT, shall not be eligible to be entered into the Draw.
6. The Prize is non-transferable and non-refundable and the Winner cannot receive cash, or an alternative item, in place of the Prize.

GENERAL

7. This Competition is open to all Bailiwick of Jersey and Bailiwick of Guernsey residents aged 16 years of age or over, except for JT employees. No purchase of any sort is necessary to enter this Competition and there is no charge to enter. Only one entry per person is permitted.
