



Design a JT Christmas Tree Competition Jersey and Guernsey
Full Promotional Terms of Reference

The Promotion is open to all Jersey and Guernsey resident children aged thirteen (13) years or under (except for the children of employees of JT) who elect to be entered into a prize draw with parental consent for the chance to win a prize between 22 November 2018 and 19 December 2018 (the "Promotional Period") by accepting these terms of reference (each an "Entrant" and together the "Entrants").

1. In order to take part in this Promotion, Entrants must, during the Promotional Period:
 - 1.1 colour in/design the Christmas tree template (a copy of which is attached to these Terms of Reference at Appendix A) (the "Template");
 - 1.2 provide all of the required information as detailed on the Template; and
 - 1.3 deliver the completed Template to one of JT's retail stores in Jersey and Guernsey.
2. The following Templates will not be valid:
 - 2.1 Templates that are incomplete by not providing all the requisite information as detailed on the Template;
 - 2.2 Templates that do not contain the requisite parental consent as detailed on the Template; and
 - 2.3 Templates that are received after the end of the Promotion Period.
3. A draw will take place at midday on Thursday 20 December 2018 (the "Draw") where JT will select the following at random:
 - 3.1 two (2) winners from the all the valid Templates received by JT, one (1) from Jersey and one (1) from Guernsey (each a "Winner" and together the "Winners"); and
 - 3.2 six (6) runners-up from all the valid Templates received by JT, three (3) from Jersey and three (3) from Guernsey (each a "Runner-Up" and together the "Runners-Up").
4. The prize that will be won by each of the Winners is a Cadbury Christmas Chocolate gift and selection box containing one (1) Christmas Selection Packs 95g, one (1) Snow Bites Bag 90g, one (1) Cadbury Minis Fudge Tube 72g, one (1) Dairy Milk Buttons Tube 72g, one (1) Cadbury Dairy Milk Winter Edition Bar 100g, one (1) Freddo Bar 18g, one (1) Freddo Caramel 19.5g and one (1) festive selection box including a festive plush toy and Cadbury favourites (the "Winner Prize").
5. The prize that will be won by each of the Runners-Up will be one (1) festive selection box including a festive plush toy and Cadbury favourites (the "Runner-Up Prize").

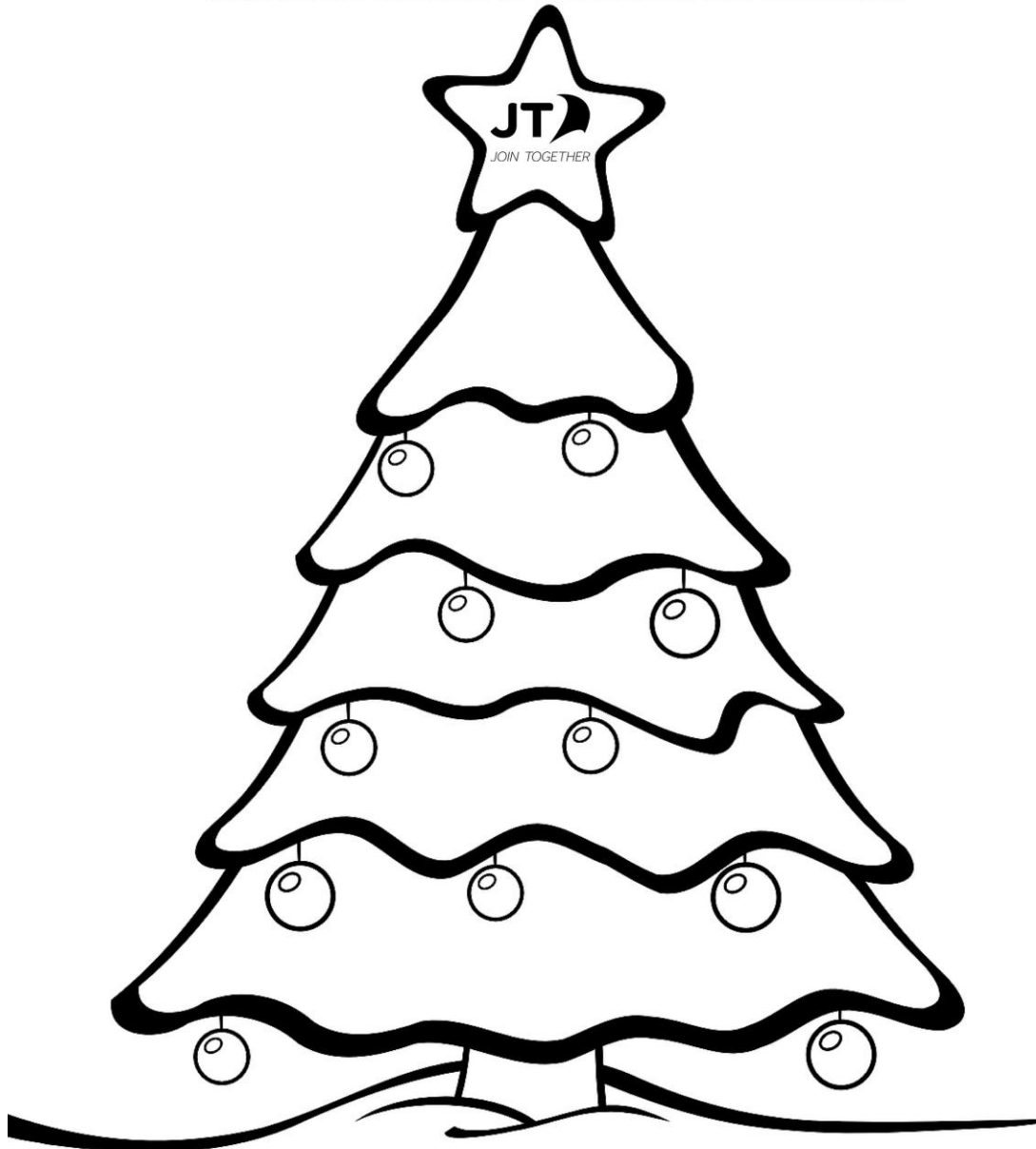
6. Each Winner and Runner-Up shall be contacted via the contact details provided on the Template and will be able to collect their respective Winner Prize and Runner-Up Prize on Saturday 22nd December 2018 (the "Collection Date") from one of JT's retail stores in Jersey and Guernsey. JT shall make all reasonable efforts to contact the Winners and Runners-Up and/or their parents before the Collection Date using the contact details provided on the Template. However, if the Winners and/or Runners-Up and/or their parents do not respond to the notification from JT before the Collection Date then JT reserves the right to select a new Winner or Runner-up at random in their stead.
7. The Winners and Runners-Up and/or their parents who attend the retail stores in Jersey and Guernsey to collect their Winner Prize and/or Runner-Up Prize must bring photo identification and will be subject to a full verification process to the satisfaction of JT's retail staff. The decision of JT in this regard is final.
8. If the Winner Prize and/or Runner-Up Prize provided under this Promotion is not collected by the Winner and/or Runner-Up and/or their parents on the Collection Date it may be, at JT's sole discretion, collected at a later date provided that the Winner and/or Runner-Up collects the Winner Prize and/or Runner-Up Prize within a period of one (1) month from the Collection Date.
9. The Winner Prizes and Runner-Up Prizes are subject to availability. JT retains the right to substitute the Winner Prizes and/or Runner-Up Prizes with another prize of a similar value where the Winner Prize and/or Runner-Up Prize are not available. No cash alternative is available.
10. By entering this Promotion, Entrants (subject to obtaining and providing the additional parental consent) agree that their name and photograph may be used by JT for reasonable publicity purposes in connection with this Promotion.
11. Times and dates for the Draw may be subject to change. JT retains the right to change the date and time of the Draw for any reason whatsoever in its sole discretion.
12. Each Entrant can only be selected to win either one (1) Winner Prize or one (1) Runner-Up Prize as part of this Promotion. The Winner Prizes and Runner-Up Prizes are non-transferable and non-refundable and each Winner and Runner-Up cannot receive cash, or an alternative item, in place of the Winner Prize and Runner-Up Prize.
13. The decision of JT is final and JT will not enter into correspondence relating to its decision. JT reserves the right to modify or withdraw the Promotion at any time without prior notice.
14. No purchase is necessary to enter this Promotion.
15. By participating in the Promotion the Entrant acknowledges and consents to JT handling their personal information. JT may also use the Entrant's personal information to keep them updated with news about JT's products and services using the contact details provided. JT may share the Entrant's information with other affiliates of JT Group Limited and they may send the Entrant details of other goods and services, which may be of interest. If the Entrant does not wish to receive marketing communications, the Entrant must inform JT via its website, www.jtglobal.com.
