

## PAYG Christmas Giveaway Prize Draws - Christmas 2018 Promotion Specific Terms of Reference

- 1. The Promotion is only available Pay As You Go Customers who:
  - 1.1 download the JT My Top Up application from the Apple Appstore or an Android equivalent application store, press the "Christmas Giveaway" button and complete the online form; or
  - 1.2 (where such Pay As You Go Customer's mobile handset does not permit the downloading of applications) enter by post by sending their contact details (name, mobile telephone number, email address and postal address) to: JT PAYG Christmas Giveaway, No 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB.
- 2. A Pay As You Go Customer who signs up to the Promotion under Clause 1 above during the Promotional Period is entitled to be included on a list of entrants who may be selected to receive a prize under this Promotion (each, an "Entrant" and together the "Entrants").
- 3. The selection of an Entrant to win a prize will take place on the dates and times provided in the following table (each, a "Draw" and together the "Draws"):
