



## Design a JT Pumpkin Competition Jersey and Guernsey Full Competition Terms of Reference

### PROMOTER

1. The promoter of this competition is JT (Jersey) Limited of No 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB (“JT”).

### THE COMPETITION

2. The chance to win a prize by colouring in/designing the Pumpkin template and delivering same to one of JT’s retail stores in Jersey or Guernsey (the “**Competition**”) between 1 October 2019 and 29 October 2019 (“the “**Competition Period**”).
3. To enter the Competition, each entrant must complete **all** of the following steps during the Competition Period:
  - 3.1 colour in/design the Pumpkin Template (a copy of which is provided at Appendix 1 of these terms of reference) (the “**Template**”);
  - 3.2 provide all of the information required as detailed on the Template;
  - 3.3 have the Template signed by a parent/guardian; and
  - 3.4 deliver the Template to the relevant JT retail outlet in Jersey or Guernsey.
4. JT will select two (2) winners at random (one (1) from all valid Competition entries in Jersey and one (1) from all valid Competition entries in Guernsey (each a “**Winner**” and together the “**Winners**”) and six (6) runners up (three (3) from all valid Competition entries in Jersey and three (3) from all valid Competition entries in Guernsey (each a “**Runner Up**” and together the “**Runners Up**”) on Wednesday 30 October 2019 (the “**Draw**”).
5. The Winners shall each receive a Spooky Halloween Sweet Hamper containing Jelly Bones (200g), Fizzy Snakes (200g), Candy Skulls (200g), Jelly Pumpkins (200g), Mini Chocolate Pumpkins (200g), Green Paintball Marshmallows (100g), Jelly Brains (100g), Jelly Filled Skulls (100g), Giant Jelly Spiders (x4), Yellow Bellies (x3), Spooky Mix Bio-degradable bag zero plastic (x1), Toxic Waste (x1), Blood Bag (x1), Chocolate Witch (x1), Chocolate Pumpkin (x1) and Fizz Whiz (x4) (together the “**Winner Prize**”).
6. The Runners Up shall each receive a Halloween Spook Buddies Treat Box containing Cadbury Goo Head Egg (x1), Milkybar Character (x1), Smarties Character (x1), Mini Sweets Bag (x1) and other Halloween treats (together the “**Runner Up Prize**”).
7. Competition entries that have not completed each of the required steps set out above at paragraphs 3.1-3.4 shall not be entered into the Draw.
8. The Winner Prize and Runner Up Prize (together the “**Prizes**”) are non-transferable and non-refundable and each Winner and Runner Up cannot receive cash, or an alternative item, in place of the Prize.

## GENERAL

9. The Competition is open to all Jersey and Guernsey residents aged under sixteen (16) years of age except for JT employees and the children of JT employees. No purchase of any sort is necessary to enter the Competition and there is no charge to enter. Any additional costs incurred are the responsibility of the parent of the Competition entrant.
10. The parent of each Winner and Runner Up shall be contacted via the contact details provided on the Template and the Prize will be available for collection from Thursday 31 October 2019 (the "**Collection Date**") from the relevant JT retail store in Jersey or Guernsey.
11. JT shall make all reasonable efforts to contact the parents of Winners and Runners Up before the Collection Date using the contact details provided on the Template. However, if no response to notification from JT is received before the Collection Date then JT reserves the right to select a new Winner or Runner-Up at random.
12. Winning Prize claims are subject to a full verification process and a Prize may not be claimed without valid confirmation by JT as to the identity of the parent of the winner of the relevant Prize. JT's decision in this regard shall be final.
13. Subject to receiving parental consent, the Winner and Runner Up may have their name and photograph taken collecting their Prize which may be used by JT for reasonable publicity purposes in connection with this Competition.
14. JT may vary or terminate the Competition at any time in its absolute discretion. By participating in the Competition, the parent of each entrant agrees to be bound by these conditions. All instructions issued by JT in relation to the Competition form part of these conditions.

## LIABILITY

15. To the full extent permitted by law, JT and its associated companies and any agencies (the "**Relevant Parties**"), exclude all liability for any loss (including any damage, claim, injury, cost or expense) whatsoever which is suffered or incurred by any person arising out of, or in any way connected with the Competition or a Prize including without limitation:
  - 15.1 Any direct, indirect, economic or consequential loss; or
  - 15.2 Any loss arising from any negligent act or omission of any Relevant Parties.

JT will not accept liability for any entries lost or damaged, nor for any associated costs to claimants.

## DATA PROTECTION

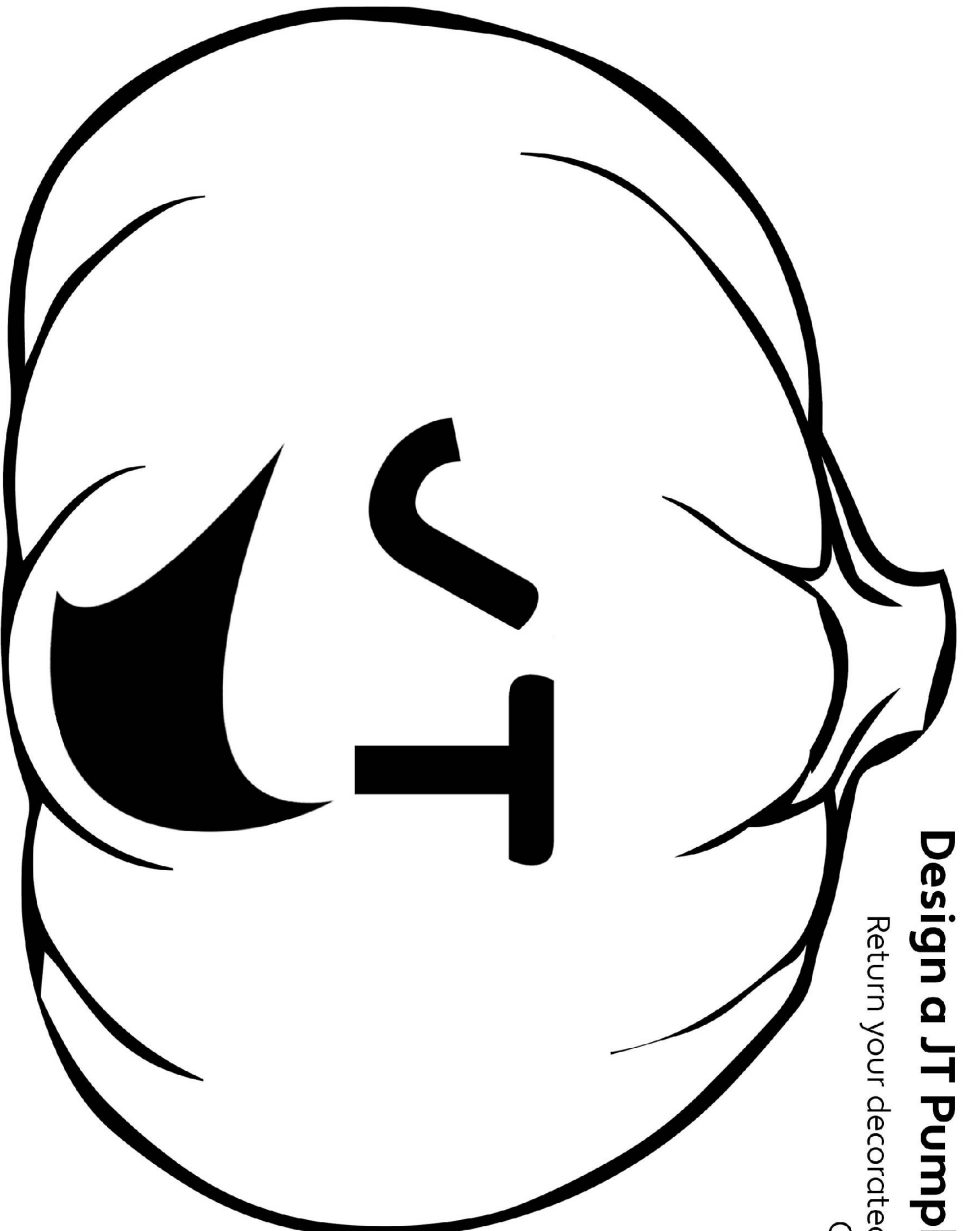

All personal data collected on the Template is being collected solely for the purposes of the Competition and will be deleted after the Competition has concluded.
