



## JT One Spring Voucher Promotion 2023 Promotion Specific Terms of Reference

1. This offer is available to new and existing Customers of JT One in Jersey who sign or re-sign to a JT One Ultra or JT One Lite plan (each a “**Plan**” and, together, the “**Plans**”) for a minimum contract period of twenty-four (24) months between 20 March 2023 and 30 June 2023 (the “**Promotional Period**”).
2. A new or existing Customer of JT signing up or re-signing up to a JT One Ultra plan in Jersey for a minimum contract period of twenty-four (24) months during the Promotional Period will be entitled to receive the following:
  - (a) a voucher to the value of £150 to be used a credit on the Customer’s account (the “**£150 Voucher**”).
3. A new or existing Customer of JT signing up or re-signing up to JT One Lite plan in Jersey for a minimum contract period of twenty-four (24) months during the Promotional Period will be entitled to receive the following:
  - (a) a voucher to the value of £75 to be used a credit on the Customer’s account (the “**£75 Voucher**”).
4. Only one (1) £150 Voucher or one (1) £75 Voucher (each a “**Voucher**”) is available per Customer. A Customer may not purchase more than one (1) Plan for the same landline telephone number.
5. This offer is only available to new and existing Customers of JT signing or re-signing to a Plan for a minimum contract period of twenty-four (24) months directly in JT’s retail outlet in Jersey or online at <https://www.itglobal.com/jersey/jt-one/>. To be eligible to re-sign and receive the offer existing Customers must have reached the end of the minimum twenty-four (24) month term of their extant Plan.
6. The Voucher will be issued at the time the Customer signs or re-signs to the Plan.
7. If a Voucher is not taken by the Customer at the time they sign or re-sign to the Plan, the Voucher may at JT’s discretion be issued to the Customer at a later date provided that the Customer claims the Voucher within a period of one (1) month after the Customer has signed or re-signed to the Plan.
8. The £150 Voucher and £75 Voucher can be redeemed to settle JT account invoices but cannot be used against Top Ups and can only be redeemed against products with a higher value than the relevant £150 Voucher or £75 Voucher value.
9. The offer is non-transferable and non-refundable and Customers cannot receive cash, or an alternative item, in place of a Voucher.
10. This offer may not be taken in conjunction with any other promotion offered by JT during the Promotional Period for a Plan.

12. A cooling-off period of fourteen (14) days applies to the Plans but will only be accepted if the Voucher is returned to JT unused. A Customer who cancels a Plan during the cooling-off period who has redeemed a Voucher will be charged the full, face value of the Voucher.
