



JT One Free Gift Promotion 2019 Promotion Specific Terms of Reference

These Terms of Reference are provided in addition to and must be read in conjunction with the JT One terms of reference for JT (Jersey) Limited and JT (Guernsey) Limited (together “**JT**”), which are available at <https://www.jtglobal.com/jersey/jt-one/> and <https://www.jtglobal.com/guernsey/jt-one/> . Unless otherwise specified, terms used in these Terms of Reference have the same meaning as defined in the JT One Terms of Reference.

1. This offer is available to:
 - a. new Customers of JT; and
 - b. existing Customers of JT who have completed at least twenty-one (21) months of the twenty-four (24) month term of:
 - i. An extant £39 per month or £49 per month JT One Plan in Guernsey; or
 - ii. An extant £40.95 per month or £61.95 per month JT One Plan in Jersey(together an “**Existing Customer**”),

who sign or re-sign up to one of the £39 per month or £49 per month JT One Plans in Guernsey or the £40.95 per month or £61.95 per month JT One Plan in Jersey (the “**Plans**”) for a minimum contract period of twenty-four (24) months between 15 March 2019 and 31 October 2019 in Guernsey and Jersey (the “**Promotional Period**”).

2. A new Customer signing up to the £49 per month plan in Guernsey for a minimum contract period of 24 months during the Promotional Period will receive:
 - 2.1 A free gift of JT’s choice, while stocks last; and
 - 2.2 The first three (3) months of the £49 per month service for free.
3. A new Customer signing up to the £39 per month plan in Guernsey for a minimum contract period of 24 months during the Promotional Period will receive:
 - 2.3 A free gift of JT’s choice, while stocks last; or
 - 2.4 The first three (3) months of the £39 per month service for free.
4. An Existing Customer signing up to the £49 per month plan or £39 per month plan in Guernsey for a minimum contract period of twenty-four (24) months during the Promotional Period will receive a free gift of JT’s choice, while stocks last.

5. A new or Existing Customer signing up to the £61.95 per month plan in Jersey for a minimum contract period of twenty-four (24) months during the Promotional Period will receive a free gift of JT's choice, while stocks last.
6. Only one free gift is available per Customer. A Customer may not purchase more than one of the Plans for the same landline telephone number.
7. This offer is only available to new Customers and Existing Customers signing or re-signing to any of the Plans for a minimum contract period of twenty-four (24) months directly in JT's retail outlets in Jersey or Guernsey.
8. The free gift will be issued at the time the Customer signs or re-signs to any of the Plans for a minimum contract period of twenty-four (24) months.
9. If the free gift is not taken by the Customer at the time they sign or re-sign to any of the Plans for a minimum contract period of twenty-four (24) months, the free gift may at JT's discretion be issued to the Customer at a later date provided that the Customer claims the free gift within a period of one (1) month from the date that the Customer signs or re-signs to one of the Plans for a minimum contract period of twenty-four (24) months.
10. This offer is non-transferable and non-refundable and Customers cannot receive cash, or an alternative item, in place of the free gift.
11. This offer may not be taken in conjunction with any other promotion offered by JT during the Promotional Period in respect of the Plans.
12. A cooling-off period of fourteen (14) days applies to the Plans and a return of the free gift will only be accepted if the free gift is returned unused and in an acceptable condition. A Customer who cancels any of the Plans during the cooling-off period and returns the free gift in a condition which is unacceptable to JT, will be charged the full face value of the free gift.
