



## **JT One 3 months free OR 100GB Data and Voucher Alderney Promotion specific Terms of Reference**

These Terms of Reference are provided in addition to and must be read in conjunction with the JT One terms of reference for JT (Guernsey) Limited (“JT”), which are available at [www.jtglobal.com/guernsey](http://www.jtglobal.com/guernsey). Unless otherwise specified, terms used in these Terms of Reference have the same meaning as defined in the JT One terms of reference.

1. This offer is available to new and existing Customers who sign up to the £39 per month JT One plan for a Minimum Contract Period of twenty-four (24) months (the “**£39 Plan**”) or the £49 per month JT One plan for a Minimum Contract Period of twenty-four (24) months (the “**£49 Plan**”) in the London House retail store in Alderney between 12<sup>th</sup> September 2018 and 31<sup>st</sup> December 2018 (the “**Promotion Period**”).
2. A new or existing Customer signing up to the £39 Plan during the Promotion Period will receive:
  - 2.1 At the Customer’s choice, the first three (3) months of the £39 Plan for free (any additional bolt-ons added to what is included in the £39 Plan are not included in the first three (3) months free for the £39 Plan and the Customer will be charged extra for these) OR 100GB of Mobile data per month for each user for up to four (4) users for the Minimum Contract Period of twenty-four (24) months for the £39 Plan (the “**£39 Free Service**”); and
  - 2.2 A free Amazon or London House retail store voucher with a value of £100, while stocks last (the “**£100 Voucher**”).
3. A new or existing Customer signing up to the £49 Plan during the Promotion Period will receive:
  - 3.1 At the Customer’s choice, the first three (3) months of the £49 Plan for free (any additional bolt-ons added to what is included in the £49 Plan are not included in the first three (3) months free for the £49 Plan and the Customer will be charged extra for these) OR 100GB of Mobile data per month for each user for up to four (4) users for the Minimum Contract Period of twenty-four (24) months for the £49 Plan (the “**£49 Free Service**”); and
  - 3.2 A free Amazon or London House retail store voucher with a value of £200, while stocks last (the “**£200 Voucher**”).
4. Only one £100 Voucher or £200 Voucher is available per Customer. A Customer may not purchase more than one £39 Plan or one £49 Plan for the same landline telephone number.

5. This offer is only available to new and existing Customers of JT signing up for the £39 Plan or the £49 Plan directly in the London House retail store in Alderney.
6. The £100 Voucher or the £200 Voucher will be issued at the time the Customer signs up to the £39 Plan or £49 Plan.

If the £100 Voucher or the £200 Voucher is not taken by the Customer at the time they sign to the £39 Plan or the £49 Plan, the £100 Voucher or the £200 Voucher may at JT's discretion be issued to the Customer at a later date. Use of the £100 Voucher or the £200 Voucher is subject to any additional terms and conditions printed on the £100 Voucher or the £200 Voucher (including any stated expiry date) and/or any other terms and conditions applied by Amazon or London House when redeeming the £100 Voucher or the £200 Voucher, and JT shall not be responsible for any action taken by Amazon or London House in this respect.
9. The offer is non-transferable and non-refundable, and a Customer cannot receive cash, or an alternative item, in place of the £39 Free Service or the £49 Free Service, or the £100 Voucher or the £200 Voucher.
