



Jersey Seafaris Challenge Promotion 2019

Promotion Specific Terms of reference

PROMOTER

The promoter of this competition is JT (Jersey) Limited, No 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB.

THE PROMOTION

For your chance to win 2 x seats on an Ecrehous Seafaris trip, complete the Jersey Seafaris challenge (the “Challenge”) between 19th July 2019 and 2nd August 2019 (the “Promotional Period”).

To enter the Challenge, you must complete **all** of the following steps:

1. Visit the JTsocal Facebook or JTsocal Instagram page during the Promotional Period, and
 - “like” or “follow” the JTsocal Facebook or Instagram page, and
 - Take a screenshot when the dolphin image is displayed on the JTsocal Facebook or Instagram page, and
 - upload the dolphin image screenshot to the JTsocal Facebook or Instagram page

Entries that have not completed all steps required above shall not be entered into the draw.

JT will draw 1 winner at random from all valid entries by midday on Monday 3rd August 2019. The winner shall receive 2 x seats on an Ecrehous Seafaris trip (the “Prize”).
