

My JT Perks Prize Draws
Promotion Specific Terms of Reference

1. The promoter of the prize draws (each a “**Prize Draw**”) is JT (Jersey) Limited, No 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB (“**JT**”).
2. All capitalised terms not defined in these terms of reference shall have the meaning given in JT’s [Definitions Terms and Conditions](#).
3. From time to time, We shall offer a Prize Draw which involves the chance for customers who qualify for “My JT Perks” to win a prize, as promoted on the My JT Perks website at www.jtglobal.com/perks (the “**Website**”) and notified to customers who qualify for My JT Perks by email (where they have opted-in to receive marketing communications).
4. In order to qualify as a My JT Perks customer and enter a Prize Draw, You must:
 - (a) be an individual consumer customer of JT (not a business customer);
 - (b) have signed up to a broadband Service, post-paid mobile Service and landline Service;
 - (c) which are all on the same JT account; and
 - (d) each Service is within its applicable Minimum Contract Period.
5. In respect of each Prize Draw, We shall promote on the Website the prize available in that Prize Draw (the “**Prize**”), the opening and closing dates to enter that Prize Draw (the “**Promotional Period**”) and the entry form to enter that Prize Draw. To enter a Prize Draw, you must complete and submit the applicable entry form by the last date of the relevant Promotional Period.
6. At the end of each Promotional Period, all valid entries will be entered into the relevant Prize Draw and a winner will be selected at random (the “**Winner**”).
7. Entry into each Prize Draw is subject to Our being satisfied that:
 - (a) You qualify as a My JT Perks customer in the relevant Promotional Period in accordance with paragraph 4 above; and
 - (b) You have accurately completed all required details in the entry form.
8. Each Prize is non-transferable and non-refundable and a Winner cannot receive cash, or an alternative item, in place of a Prize.
9. This Promotion is open to all Jersey and Bailiwick of Guernsey residents aged 18 and over who qualify as My JT Perks customers in accordance with paragraph 4 above (except for employees of JT). No further purchase of any sort is necessary to enter this Promotion and there is no additional charge to enter.
10. Each Winner will be contacted via the details provided in the entry form and which We have on record for that Winner’s JT account. We shall make all reasonable efforts to contact a Winner. However, where a Winner does not respond to notification from Us within 30 days, We reserve the right to select a new Winner at random.
11. The award of each Prize is subject to a full verification process, and a Prize may not be claimed without valid confirmation by Us as to the identity of the recipient of the Prize. Our decision as to who receives a Prize is final.
12. We may vary or terminate this Promotion at any time in Our absolute discretion. By participating in this Promotion, You agree to be bound by these conditions. All instructions issued by Us in relation to this Promotion form part of these conditions.
13. To the full extent permitted by law, We and Our associated companies and any agencies (the “**Relevant Parties**”) exclude all liability for any loss (including any damage, claim, injury, cost or

expense) whatsoever which is suffered or incurred by any person arising out of, or in any way connected with, this Promotion or the Prize including without limitation:

- (a) any direct, indirect, economic or consequential loss; or
- (b) any loss arising from any negligent act or omission of any of the Relevant Parties.

14. We will not accept liability for any fault or defect connected with a Prize identified after receipt of the Prize other than in accordance with the standard manufacturer's warranty applicable to that Prize.
