

## Pay as you go promotion 2019 Promotion Specific Terms of reference

- 1. This offer is available to new Customers who between 3 June and 1 September 2019 (the "Promotional Period") port in their mobile telephone number from another mobile telephone service provider to JT's pre-paid mobile telephone service ("PAYG") and purchase a top-up credit to the value of at least £99 to apply to their PAYG Account (the "£99 Top-Up") from JT's retail outlet in Jersey or Guernsey; or
- 2. A newly-ported PAYG Customer of JT in Jersey purchasing the £99 Top-Up during the Promotional Period will be entitled to receive a free ticket to the Weekender festival (the "Weekender Ticket").
- 3. A newly-ported PAYG Customer of JT in Guernsey purchasing the £99 Top-Up during the Promotional Period will be entitled to receive either a Weekender Ticket or a free pair of Beats onear headphones (the "**Headphones**").
- 4. A new Customer who, during the Promotional Period:
  - 3.1 ports their mobile telephone number from another mobile telephone service provider to JT's PAYG; and
  - 3.2 upon successful completion of the porting process, purchases the £99 Top-Up,

will be entitled to receive a Weekender Ticket or Headphones, while stocks last.

- 5. Only one (1) Weekender Ticket or set of Headphones is available per Customer. A new Customer may not purchase more than one (1) eligible £99 Top-Up for the same mobile telephone number.
- 6. The £99 Top Up must be purchased within seven (7) working days of the successful completion of the porting process in order to gualify for the Weekender Ticket or Headphones.
- 7. This offer is only available from JT's retail outlets in Jersey and Guernsey. The option to take the Headphones is only available in Guernsey.
- 8. The Weekender Ticket or Headphones will be issued at the time the Customer purchases the £99 Top-Up.
- 9. If the Weekender Ticket or Headphones is not taken by the Customer at the time that they purchase the £99 Top Up the Weekender Ticket or Headphones may at JT's discretion be issued to the Customer at a later date provided that the Customer claims the Weekender Ticket or Headphones within a period of one (1) month from the date the Customer purchases the £99 Top Up.
- 10. The provision of the Weekender Ticket or Headphones is subject to availability whilst JT's stock of Weekender Tickets and Headphones lasts. If JT's stock of Weekender Tickets or Headphones is exhausted prior to the end of the Promotional Period then the Promotional Period ends when JT's stock of Weekender Tickets or Headphones is exhausted.

- 11. This offer is non-transferable and non-refundable and Customers cannot receive cash, or an alternative item, in place of the Weekender Ticket or Headphones.
- 12. The £99 Top-Up will be applied to the Customer's Account at the time of purchase in JT's retail outlet and will expire ninety (90) days after being applied to the Customer's Account. The £99 Top-Up Credit or any unused portion thereof is not transferable from a PAYG Account to a post-paid account and any unused credit on the Account after the ninety (90) day period has expired will be removed from the service.
- 13. New Customers must take photographic identification with them when they visit JT's Jersey or Guernsey retail outlet to port their mobile telephone number.
- 14. This offer may not be taken by a Customer in conjunction with any other JT PAYG offer.
- 15.
