



## **JT Pool Party Instagram Challenge 2019**

### **Promotion Specific Terms of Reference**

#### **PROMOTER**

1. The promoter of this competition is JT (Jersey) Limited, No 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB.

#### **THE PROMOTION**

2. The chance to win a BoomPods Fusion BT 10W waterproof speaker, by completing the JT Pool Party Instagram Challenge (the “**Challenge**”) between 10 August 2019 and 12 August 2019 (the “**Promotional Period**”).
3. To enter the Challenge each entrant must during the Promotional Period complete all of the following steps:
  - 3.1 Take a photo at one of JT’s Pool Party events on 10 August 2019 at The Lido, Jersey or 11 August 2019 at La Valette Bathing Pools, Guernsey; **AND**
  - 3.2 Upload the photo to an Instagram account using the hashtag “**#JTPoolparty**”.
