



**Free Phone Friday Prize Draw**  
**Competition Terms of Reference**

**PROMOTER**

1. The promoter of this competition is JT (Jersey) Limited, No.1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB and JT (Guernsey) Limited, 24 High Street, St Peter Port, Guernsey GY1 2JU (“**JT**”).

**THE COMPETITION**

2. This competition involves the chance to win a free smartphone by completing an online entry form on the JT website (the “**Competition**”) between Friday 5<sup>th</sup> August & Friday 26<sup>th</sup> August 2023, (the “**Competition Period**”).
3. In order to enter the Competition each entrant must complete the online entry form available at [www.jtglobal.com/competition-free-phone-friday/](http://www.jtglobal.com/competition-free-phone-friday/) by providing a valid email address and mobile telephone contact number (the “**Entry Form**”) and agree to have a photograph taken when collecting their prize from the relevant retail store in Jersey or Guernsey.
4. JT will select a winner at random from all valid Competition entries (a “**Winner**”) each Friday during the Competition Period (the “**Draw**”).
5. Each Winner shall be entitled to receive a free smartphone (the “**Winner Prize**”).
6. Competition entrants that have not completed the Entry Form to the satisfaction of JT shall not be entered into the Draw. JT’s decision in this regard shall be final.
7. The Winner Prize is non-transferable and non-refundable and each Winner cannot receive cash, or an alternative item, in place of the Winner Prize.

**GENERAL**

8. The Competition is open to anyone aged sixteen (16) years of age or over except for JT employees. No purchase of any sort is necessary to enter the Competition and there is no charge to enter. Any additional costs incurred are the responsibility of the Competition entrant.
9. Each Winner shall be contacted via the contact details provided on the Entry Form and the Winner Prize will be available for collection during the week following the relevant Draw (the “**Collection Date**”) from the relevant JT retail store.
10. JT shall make all reasonable efforts to contact each Winner using the contact details provided on the Entry Form. However, if no response to notification from JT is received within (5) working days of the Collection Date then JT reserves the right to select a new Winner at random.
11. Winner Prize claims are subject to a full verification process and the Winner Prize may not be claimed without valid confirmation by JT as to the identity of each Winner. JT’s decision in this regard shall be final.
12. JT may vary or terminate this Competition at any time in its absolute discretion. By participating in this Competition, each entrant agrees to be bound by these



conditions. All instructions issued by JT in relation to this Competition form part of these conditions.
