

# VIP Weekender Ticket Promotion 2019

## Promotion Specific Terms of Reference

### PROMOTER

1. The promoter of this Promotion is JT (Jersey) Limited, No 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB.

## THE PROMOTION

- 2. This Promotion involves the chance to win two (2) VIP tickets to the Weekender festival in Jersey, which takes place on 31 August and 1 September 2019 (the "Weekender"), by going to either of the JTsocial Facebook or Instagram social media pages between 9 and 22 August 2019 (the "Promotional Period") and completing <u>all</u> of the following steps:
  - 2.1 "Like" the JTsocial Facebook page or "Follow" the JTsocial Instagram page;
  - 2.2 Post a festival photo with a friend in the Facebook comment box or post a photo on Instagram using the hashtag "#summertogetherwithJT"; AND
  - 2.3 Tag a person to party together with at the Weekender.
- 3. JT will draw one (1) winner at random from all valid entries by midday on Friday 23 August 2019 (the "**Draw**") and the winner will receive two (2) VIP Weekender tickets (the "**Tickets**").
- 4. Challenge entrants that have not completed each of the required three (3) steps set out at 2.1-2.3 above, shall not be eligible to be entered into the Draw.
- 5. The Tickets are non-transferable and non-refundable and the winner cannot receive cash, or an alternative item, in place of the Tickets.
