



VIP Super League Triathlon Ticket Promotion 2019

Promotion Specific Terms of Reference

PROMOTER

1. The promoter of this Promotion is JT (Jersey) Limited, No 1 The Forum, Grenville Street, St Helier, Jersey JE4 8PB.

THE PROMOTION

2. This Promotion involves the chance to win two (2) VIP tickets to the Super League Triathlon in Jersey, which takes place on 28th & 29th September 2019 (the “**Super League Triathlon**”), by going to either of the JTsocal Facebook or Instagram social media pages or entering via the entry form at: www.jtgglobal.com/superleague between 28th August and 20th September 2019 (the “**Promotional Period**”) and completing the following steps:
 - 2.1 “Like” the JTsocal Facebook page, “Follow” the JTsocal Instagram page or enter via www.jtgglobal.com/superleague;
 - 2.2 Tag a person you would take with you to the Super League Triathlon.
3. JT will draw one (1) winner at random from all valid entries by midday on Friday 20th September 2019 (the “**Draw**”) and the winner will receive two (2) VIP Super League Triathlon (the “**Tickets**”).
