



Win a Christmas Tech Bundle Competition – November 2022 Terms of Reference

PROMOTER

THE COMPETITION

2. The chance to win a ‘Tech Bundle’ by scanning the competition QR code and completing the online “Christmas Tech bundle” Competition entry form at the JT website shop.jtgglobal.com/competition (the “**Competition**”) between 17 November 2022 and 9am on 23 December 2022 (“the “**Competition Period**”).
3. To enter this Competition each entrant must, during the Competition Period, complete each of the following steps:
 - (a) Scan the competition QR code on the JT candy cane wrapper, an example of which is set out at Appendix A or visit shop.jtgglobal.com/competition; AND
 - (b) complete the online Competition entry form at shop.jtgglobal.com/competition; AND
 - (c) provide their contact details on the online Competition entry form.
4. JT will draw one (1) Competition entrant winner at random from all valid Channel Island entries (the “**Winner**”) by 5pm on 23 December 2022 (the “**Draw**”). The Winner will be entitled to a bundle of technology products including the following:
