

JT One Ultra – Win a Tech Bundle Competition Terms of Reference

PROMOTER

1. The promoter of this competition is JT (Guernsey) Limited, 24 High Street, St Peter Port, Guernsey GY1 2JU ("**JT**").

THE COMPETITION

- 2. The chance to win a bundle of technology devices by taking part in JT One Ultra On-Street Ambient Activity and carrying out the steps provided at clause 3 below (the "Competition").
- 3. To enter the Competition, each entrant must complete all of the following steps:
 - (a) attend the JT One Ultra On-Street Ambient Activity stand at Market Square, St Peter Port, Guernsey on either Saturday 5 June 2021 or Saturday 12 June 2021 (the "Event Dates");
 - (b) write down the type of "ultra" person that the entrant is on the board provided by the Black Vanilla promotional representative;
